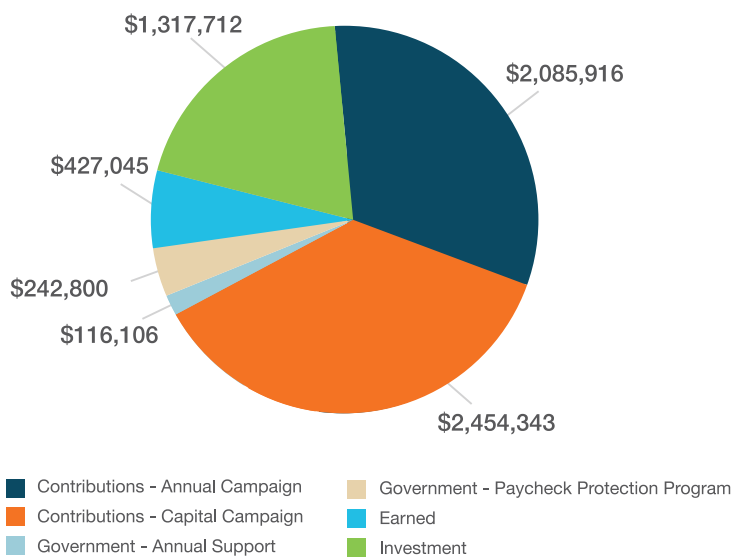


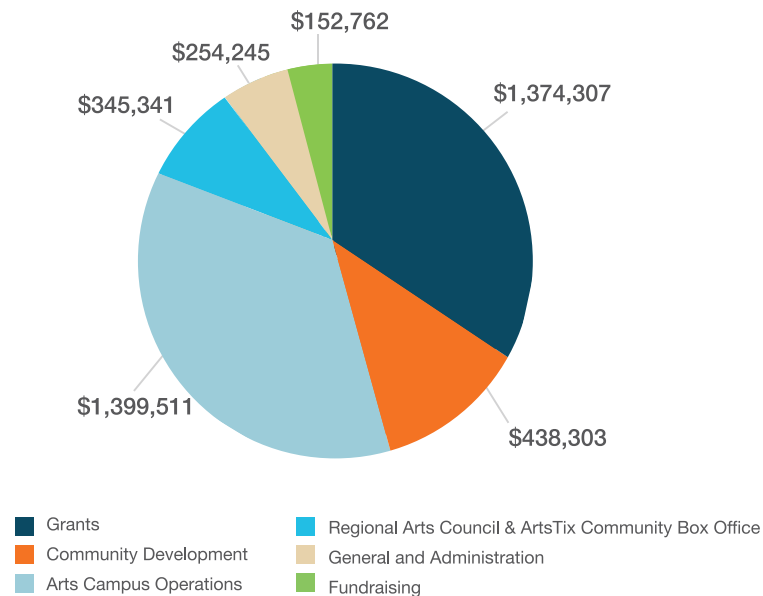

How has Arts United impacted arts and culture in Northeast Indiana?



COMMUNITY DEVELOPMENT

Arts United celebrated Taste of the Arts and the Arts United Awards, coordinated advocacy and promotion initiatives like the Arts & Culture Forecast, supported partnerships like the Fort Wayne Public Art Commission, and spearheaded cultural planning and development initiatives.



MEMBER SERVICES PROGRAM

Arts United coordinates a member services program for more than 50 arts and culture nonprofits that includes networking, professional development, shared business services and box office, and advocacy initiatives. Through shared services, pooled insurance, and below-market rental rates, Arts United saved member organizations and their 191 employees more than \$1.7 million. In 2021, the members of the Regional Arts Council worked with True North Strategic Advisers to plan for the future of this program thanks to a three-year grant from the Foellinger Foundation.



GENERAL ADMIN & FUNDRAISING

Arts United is led by a 29-member Board of Directors and employed 19 full-time and 28 part-time people in 2021.



GRANTS

Arts United directly managed \$1.37 million in its own grant programs, as well as administered \$394,245 in grants on behalf of the Indiana Arts Commission, totaling nearly \$1.7 million in grant support benefiting 54 organizations in Northeast Indiana.



ARTS CAMPUS OPERATIONS

Arts United owns and operates four of the seven facilities of Arts Campus Fort Wayne – Arts United Center, Auer Center for Arts & Culture, Hall Community Arts Center, and Parkview Physicians Group ArtsLab. Arts Campus Fort Wayne was designated as a Local Cultural District by Fort Wayne City Council and a State Cultural District by the Indiana Arts Commission in 2021. Although not yet included in Arts United's financial statements, the Capital Improvement Board, City of Fort Wayne, and Allen County Board of Commissioners committed a total of \$9 million toward the future renovation of the Arts United Center.
